## APPLICATION

**DASIC AEROKLEEN ACS** should be diluted at a rate of 1 part Dasic Aerokleen ACS to 10 parts water. This may be applied by cloth, brush or spray. Following a suitable contact time, the dissolved deposits may be removed with a damp cloth without streaking. Rinse surface with a clean wiper saturated with clean water and wipe surface dry with clean dry cloth.

### FLOTEX SCRUBBING PADS

Agitation using **FLOTEX** 4 x 4 scrubbing pads (available from DASIC International Ltd) accelerates the removal of ingrained soiling on matt or dimpled surfaces (food trays, polycarbonate seat backs etc) prior to removal of the dissolved deposits with a damp cloth.
